#### PLEASE CAREFULLY FOLLOW THE MANUSCRIPT TEMPLATE GUIDELINES. Manuscript template (six to eight pages) / Extended abstract template (not more than two pages)

Please ensure your submission meets the conference's strict guidelines for accepting abstract, accounts of practice or e-poster: Your abstract should include the following sections:

- A title for the paper.
- An introductory statement to discuss the paper background and the significance.
- A succinct description of the preferred methodologies.
- A clear indication of the major findings of the research.
- A concluding statement.
- Five keywords listed in alphabetical order.
- Do not include any references or figures in the abstract.
- The abstract must be written in the third person and plain English.
- Abstract should not exceed (**300 words**) and accounts of practice or workshops (**150 words**).
- Add a brief biography about yourself [not more than 100 words].
- Please choose the type of session that you would like to attend.

#### **Information for Authors**

- All research papers must be original and not previously submitted to or be under consideration for publication for another journal while being reviewed by our conference scientific panel.
- 2) Authors who wish to have papers for inclusion in our prestigious conference proceedings and journals must be approved for publication by the academic peer-review process. We require full manuscripts to be submitted for review by no later than **31st July 2023**.
- 3) Titles of working papers not relevant to the themes covered may not be accepted and will be excluded from the conference process.
- 4) All manuscripts must be written in English, and the paper length should be between six- and eight-pages including figures, tables, photos, and references.
- 5) All manuscripts will be double-blind reviewed by at least two reviewers and will be published in the ICIET conference proceedings.
- 6) Selected full papers will be sent for review for potential publishing in designated education-oriented journals.
- 7) If your abstract is accepted by the Scientific Committee, which means you will be presenting virtually at the ICIET, endeavour to submit a full paper through the **Online Submission Platform**.

#### Academic Review Process

Papers submitted are considered for review if they are original and have been neither submitted to, nor published in, another publication. Simultaneous submission to other publications will result in immediate rejection of the paper and exclusion from the process. All abstracts submitted for this summit will be assessed by the Scientific Committee to establish the following:

- Relevancy
- Originality
- Accuracy
- Technical matters
- Research depth



All papers are put through a comprehensive and rigorous, fair, unbiased peer review and refereeing procedure, and are considered because of their significance, novelty, and usefulness to the conference readership. The peer review process ensures the anonymity of the referees & it will be reviewed by at least three subject specialists in the area. The review outcome will be one of the following decisions:

- 1) Accept with no changes.
- 2) Accept with minor changes.
- 3) Accept with major changes.
- 4) Reject and remove for the process.

The review process may take approximately (4 – 8 weeks) to be completed. The peer-review panel along with the 'Editor and Scientific Committee' reserve the right to reject a paper if it does not meet the conference standard for publication specified by the Committee on Publication Ethics (COPE).

#### Code of Ethics and Malpractice Policy

ICIET adheres to the ethical standards specified by the COPE, including the COPE Fundamental Practices and the Tenets of Transparency and Best Practice in Scholarly Publishing.
